2. Visa applications are received on all working days Monday to Friday from 9.00 AM to 11.00 AM.
3. If any of the particulars furnished below are found to be incorrect, or if any information is found to have been withheld, the visa is liable to be cancelled at any time.
4. Application should be neatly filled in and signed by the applicant.
5. **Visa fee** for nationals of Nigeria, Benin, Cameroon and Chad: Naira 6000 (as in September 2005).

**SPECIFIC REQUIREMENTS FOR DIFFERENT CATEGORIES OF VISA**

**Business Visa:** (a) Letter of invitation from the Indian company (b) Original Company Incorporation Certificate with a copy and (c) any other relevant documents relating to past business with India. Interview may be required.

**Student Visa:** (a) Proof of admission to a full-time course in a recognized/reputed educational institution in India. (b) For medical or para-medical courses, a "no objection certificate" from the Ministry of Health, Government of India. (c) An affidavit from the Parent/Guardian that they will be responsible for regular remittance of funds to the student to continue his study in India and evidence of adequate funds or traveler's cheques/BTA for at least first four months sustenance in India.

*All students are advised to seek extension of their stay in India from the local Foreigners' Regional Registration Office.*

**Medical (M) Visa:** Document from hospital/doctor of country of origin/residence recommending specialized medical treatment and acceptance letter from reputed/recognized specialized hospital/treatment center in India. Family members/attendants of patients coming to India for medical treatment are issued "MX" visa.

**Note:** *Foreigners coming to India on "M"/"MX" visa are required to get themselves registered mandatorily with the local Foreigners Registration Office within 14 days from the date of arrival.*
